KEY CHILD PROTECTION POLICIES IN SCHOOL

Category	Policy Details & Action Protocols
1. Safety & Security	- CCTV Surveillance: 24x7 monitoring at gates, corridors, and common areas. - Frisking: Daily frisking of support staff and random checks during school hours. - Entry Protocol: No entry without ID card. Visitors allowed only after verification. - Transport: All vans/buses have GPS, attendant, and emergency contact display.
2. Personal Safety Education	- Good Touch - Bad Touch: Age-appropriate workshops conducted every term. - Student Feedback: Confidential feedback taken from students on safety quarterly. - Complaint Mechanism: Suggestion/Complaint Box and School Counsellor available. - Helpline: Child Helpline 1098 and POCSO Committee details displayed.
3. Code of Conduct for Staff	- Background Verification: Police verification done for all staff members. - No Physical Punishment: Strictly prohibited as per RTE & JJ Act regulations. - One-to-One Interaction: Not allowed in closed rooms. Door must remain open. - Mobile Policy: Staff cannot click student photos without explicit permission.

- ✓ Pick & Drop: Only authorized persons with an official ID card can take the child from campus.
- ✓ Online Safety: Please closely monitor your child's internet, applications, and mobile usage at home.
- ✓ Communication: Share any sudden behavioral change or concern regarding safety with the Class Teacher/Principal immediately.
- ✓ Workshops: Parents are requested to actively attend upcoming 'Child Safety Awareness' sessions.
